First class at 8:00 am. Please note this is not order of classes. Lunch break will be scheduled if entries permit.

- Novice classes are for horses or riders who have never shown dressage.
- Classes will be split in Adult and Jr/YR when entries permit.
- Ribbons will be awarded for 1<sup>st</sup> through 6<sup>th</sup> place and for Champion in each division with three or more riders.
- Must ride in two classes of the same level to be eligible for Champion awards. Ultimate Seat Class winners receive \$25!
- USEF approved protective headgear must be worn at all times while mounted.
- If the maximum number of entries is received prior to the closing date, the show will close early.
- Show can be cancelled for lack of entries, or poor weather. In this event, entries will be returned, **except the \$15 office fee.**
- No refunds available after closing date

- Indoor arena available for schooling throughout day; Please refrain from schooling on grass hill in order to avoid distracting competitors
